
## **Description of this fund**

The Smart US Technology (NZD Hedged) ETF invests in US shares and is designed to track the return of the S&P 500 Capped 35/20 Information Technology Index (100% NZD Hedged).

## What are the risks of investing?

Risk indicator for the Smart US Technology (NZD Hedged) ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## What fees are investors charged?

Investors in the Smart US Technology (NZD Hedged) ETF are charged fund charges. Based on the Product Disclosure Statement dated 10 October 2024, these are expected to be:

## Example of how this applies to an investor


Tara had \$10,000 in the fund on 24 October 2024 and did not make any further contributions. On 30 June 2025, Tara received a return after fund charges were deducted but before tax of \$892 (that is 8.92% of Tara's initial \$10,000). This gives Tara a total return after tax of \$862 for the period.

#### **Currency hedging**

As at 30 June 2025 the fund's exposure to assets denominated in foreign currencies was 98.98%, of which 92.82% was hedged. This means the fund's unhedged foreign currency exposure was 7.11% of the net asset value of the fund. #### **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 4 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
